### Registration Fee \$775 due with contract

This nonrefundable fee is payable with the signed contract and to secure your child's placement for the 2021-2022 academic year. Siblings of children currently have priority for registration. Please see the bookkeeper to make payments March - May of 2021.

### Annual Tuition: \$8,727 (8:00 a.m. - 3:00 p.m. Mon. - Friday)

In consideration for Capitol School's agreement to hold a class position for this student, the parents' obligation to pay for the full academic year is unconditional. After July 1, 2021, no portion of the outstanding tuition will be refunded, in case of absence, withdrawal, suspension, expulsion or departure from school unless a 2% cancellation fee is paid prior to grades provided for a transfer. Any cancellation of enrollment must be in writing and received before July 1, 2021 to relieve the obligation of paying the tuition in full. Tuition includes printing, books, supplies, sports, insurance, day trips and transportation for the year. The school's access control system to classrooms can only be used during school hours by a "key pad" included in this fee. There will be optional book & photo orders, fruit sale, Boston Butt sales, T-shirts, and lunches sponsored by our **Capitol School Parent Teacher Council**.

**Afternoon Explorations: \$1,881** This fee of \$11 per afternoon provides instruction and care all year from 3:00 - 5:30 p.m. Monday - Friday. The fee may be added to your monthly payments but we must know by July 1st if your child will attend.

**Technology Fee \$200 due Aug. 12** This fee will purchase new desk top computers, iPads & apps for Mrs. Amundson's Cluster.

**Capital Improvement Fee: \$330 due Nov. 1** This fee funds the improvement of school facilities/equipment and a scholarship fund. It includes \$30 for your family's membership to the PTC.. This fee is discounted one dollar for every dollar donated to **Capitol Foundation**, an IRS Section 501(c)(3), deductible for federal income tax purposes using the Foundation's tax ID #63-1203794.

# 2021 - 2022 Capitol School Ages 7 - 9 Contract

The Capitol School offers three options for payment of tuition. Please mark your choice:

● **Option #1** – The parents/guardians pay the annual tuition and fee in one lump sum payment of \$8,727 due by July 1, 2021.

● **Option #2** – The parents/guardians pay monthly by Bank First draft with 4% interest on the fifth of each month August through May.

Please circle the items you choose for your child:

10 monthly payments

\$8,727 tuition + \$349 (4%) = \$9,076 or \$908 mo.

\$1,881 extended day + \$75 (4%) = \$196 mo.

● **Option #3** – The parents/guardians pay monthly in the school office by credit card. This option adds the 2.85% charged by the credit card company to the 4% interest charge.

## Other Terms and Conditions of Enrollment

**Alabama Immunization Card** – This health card or a religious waiver *must* be on file in the school office before the first day of class.

**School Day** --The school day begins at 8:00 with a teacher on duty at 7:30 at no additional charge to support working parents. School ends at 3:00 p.m. with our *Afternoon Explorations* providing instruction and activities M-F until 5:30 p.m. Children not picked up by 3:00 will be brought to the school office to wait. You may pick up earlier than 5:30 p.m. Call the office if you have an emergency and need care for one afternoon.

**School Year** – The calendar school calendar. To help support working parents, “Break Camp” can be reserved for \$40 per day for most school holidays.

**Admission Policy & Handbook** – All new and returning students must comply with admission policies, handbook and rules established by school faculty.

**Parent Service Commitment** – The Capitol School is a partnership of school and family. Parents/guardians agree to contribute 36 hours per year as a volunteer.. This time may be contributed weekly, monthly, or accrued for a special event such as a fieldtrip or planning a school event. Parents can track volunteer hours online.

**Parent/Teacher Communication** – Required parent-teacher conferences are held in August, October and March. Additional conferences can be scheduled convenient for parents’ schedules. Newsletters, emails, texts, Brightwheel and *Remind* will enable communication between parents & faculty.

**Parent Council** – Our goal is 100% membership in our Parent Council. One membership is included but grand-parents are welcome to join for a \$30 annual membership fee. Attendance at parent conferences and school events count toward hours.
