This nonrefundable fee is payable with the signed contract to secure your child's placement for the 2020–2021 academic year. Your child must be 30 months old (2.5 years) and "potty trained" as DHR doesn't allow diaper changing facilities for our license.

In consideration for holding a class position for this student, the parents' obligation to pay the fees for the full academic year is unconditional. After July 1, 2021, no portion of the outstanding fees will be refunded or cancelled, in whole or in part, due to absence, withdrawal, suspension, expulsion or departure from school. Cancellation of enrollment must be in writing and received before July 1, 2021, to relieve the obligation of paying the tuition in full. Siblings of children currently enrolled are given priority for registration. On March 18, registration opens to parents whose children are on the waiting list and to the general public.

There will also be optional book & photo orders, Boston Butt sales, T-shirts sales by our Capitol School Parent Teacher Council.

Technology Fee \$50.00 due Aug. 12 This fee will purchase two new iPads and Montessori apps for both preschool clusters.

Capital Improvement Fee: \$330.00 or more due by November 1, 2021.

This fee funds the acquisition and improvement of school facilities/equipment and a scholarship fund. Membership in Capitol School's PTC is also included. This fee will be discounted one dollar for every dollar donated to Capitol Foundation on the student's behalf. 2021 - 2022 Capitol School Preschool Contract

The Capitol School offers three options for payment of tuition. Please mark your choice:

Option #1 – The parents/guardians pay the annual tuition and fees by July 1 in one lump sum: \$8,975 full time

Option #2 – The parents/guardians pay tuition (includes 4% interest) by bank draft to Bank First on the 5th of each month for 10 payments.

Other Terms and Conditions of Enrollment

Alabama Immunization Card – This Alabama health card or a religious waiver must be on file in the school office before the first day of class for any student to attend.

School Year – The online parent survey held in February determined parent preferences for the 2020-21 school calendar. To help support working parents, "Break Camp" can be reserved for \$40 per day for most school holidays.

Admission Policy & Handbook – All new and returning students must comply with admission policies, handbook and rules established by school faculty. **Summer Explorations** – Ten summer classes will be offered by our current Preschool staff across 5 summer sessions with a morning 8:00 - 12:00 morning session and a 1:00 - 5:00 afternoon session. You may choose any sessions for your child at a cost of \$250 per class using the online registration process.-Some classes have additional fees.

Parent Service Commitment – The Capitol School is a partnership of school and family. Parents/guardians agree to contribute 36 hours per year as a volunteer. This time may be contributed weekly, monthly, or accrued for planning or attending a school event. Parents can track volunteer hours online.

Parent/Teacher Communication – Required parentteacher conferences are held in August, October and March. Additional conferences can be scheduled convenient for parents' schedules. Newsletters, emails, texts and *Remind* will enable communication between parents and faculty.

Parent Council – Our goal is 100% membership in our Parent Council. One membership is included but grandparents are welcome to join for a \$30 annual membership fee. Attendance at parent conferences and school events count toward hours.
